Most sadly, Professor Emeritus Takahashi Junjirō, a Trustee, passed away on March 22, 2013. On March 31, 2013, there were 14 Trustees, 20 Councilors and 2 Auditors.

II. Personnel

During the fiscal year 2012, no new employee was hired and one person resigned. The total number of employees as of March 31, 2013, stood at 12 (5 men; 7 women).

IV. General Affairs

A. Roppongi 5-chome West District Urban Area Redevelopment Preparatory Association

The House has been participating in the Roppongi 5-chome West District Urban Area Redevelopment Preparatory Association established on March 26, 2008, to study possible future planning for the area. Asked by the local residents to participate as an important preservationist of the cultural and historical heritage as well as for its valuable green environment in an urban area, the House decided to join in the association. Not only for good relations with neighbors, but also for keeping up with the current status of the area, it is informative and instructive for the House to share views and opinions in its neighborhood.

V. Building and Equipment

From July to September 2012, we did repair work on the outer wall and the terrace of the west building, which had some conspicuous aging degradation. In August, we replaced part of the outdoor lighting of the parking lot, which also had conspicuous damage in addition to aging.

Furthermore, with the hope of meeting the needs of visitors, including our members, we set up a wireless local area network (LAN) in our facilities, including the hotel rooms and individual study rooms, in September and added a new nameplate to the stone wall of the main entrance in November 2012. From December 2012 to January 2013, we updated the computer server as well as the terminals, as the operating system we had been utilizing at the office approached the end of its term. In addition, we completed the relaunching of our website in January 2013, which was thoroughly redesigned and enriched.

Membership

I. Individual Membership

Fiscal 2012 saw a total of 80 persons (63 Japanese and 17 other nationalities) accepted onto the rolls of House membership. This total is 12 less (9 less Japanese and 3 less of other nationalities) than last year.

There were a total of 162 members (98 Japanese and 64 other nationalities) lost owing to resignation, death, or delinquency of dues, 26 less (20 less Japanese and 6 less of other nationalities) than the figure for last year.

Accordingly, this brought a net decrease in membership of 82 (35 Japanese and 47 of other nationalities) and the total regular membership stood at 2,987, of whom 2,074 were Japanese and 913 individuals of 40 different nationalities and areas, as of March 31, 2013.

II. Corporate Membership

During fiscal 2012, there were a total of 9 new corporate members totaling 9 support units; this total is 6 more members and 6 more units than last year. At the same time, 16 members and 24 units withdrew.

There was thus a net decrease of 7 members totaling 15 units, bringing the total to 182 corporate members with 217 units as of March 31, 2013.

III. Honorary Membership

Honorary membership has been abolished as a category of membership with no new honorary members replacing those leaving Japan. The total honorary membership stood at 1 as of March 31, 2013.

IV. Library Membership

With 32 new library members and 25 withdrawals, the total library membership stood at 124, representing 18 nationalities, as of March 31, 2013.

V. Total Income

Income from individual membership in the 2012 fiscal year, including library membership dues, netted \$65,680,398, or \$1,173,895 less than in the same period of the last fiscal year, and income from initial donations was \$8,700,000, or \$1,500,000 less than the corresponding figure for the previous year. Income from corporate membership totaled \$35,334,560, or \$2,705,940 less than the same period in the last fiscal year.

Program and Activities

The year 2012 marked the sixtieth anniversary of the International House of Japan. Several special programs were organized to commemorate the anniversary, in addition to regular programs.

A. The IHJ Sixtieth Anniversary Programs

1. Photo Exhibition: The International House of Japan in the History of Cultural Exchange in Postwar Japan

A photo exhibition was held to look back upon the history of the International House of Japan, which has facilitated creative thinking and intellectual dialogue for the last sixty years. As the political, economic, and cultural landscape surrounding Japan changes, so does the purpose, geographical scope, and modality of cultural exchange. This exhibition was also an occasion to ponder the future role of culture and intellectual exchange in international relations. In addition to visual images representing the intellectual activities of the I-House, other cooperating cultural organizations were introduced.

Period: September 1-November 30

Venue: Lobby

2. Special Symposium "Japan in the World"

This series of symposiums examined how Japan should proceed in the international arena and the role it should play. In the first two symposiums, two specialists were invited to talk about how Japan has responded to international events historically and discuss the current role of Japan in the world. In the latter symposiums, leading personalities from the United States, China, Korea and Southeast Asia were invited to talk about what they expect from Japan and the role it should assume in the international community. The program was sponsored by the Japan Foundation and the Tokyo Club.

The content of this series is scheduled to be published by Iwanami Shoten in July.

B. Regular Programs

1. Encouragement of Intercultural Intellectual Dialogue

To better understand and articulate the various challenges faced by the global community in the 21st century, I-House organizes programs which bring together people from different cultural/social backgrounds and professions to engage in interdisciplinary, multilayered intellectual dialogue in the humanities, social and natural sciences.

a. Asia Leadership Fellow Program

In joint cooperation with the Japan Foundation, the I-House has organized the Asia Leadership Fellow Program (ALFP) since 1996, and nearly a hundred fellows have participated in the program to date. In 2012, to review the program, a special symposium featuring some ten past ALFP fellows was held to think about the future of the civil society in Asia. b. I-House Ushiba Fellowship

Made possible by the endowment subsequent to the dissolution of the Ushiba Memorial Foundation, this exchange program invites distinguished contemporary thinkers and intellectuals to Japan for the purpose of bringing humankind closer together and transcending the North-South/East-West divides through the enhancement of international understanding. There was no visitor during the period under review, but we made preparatory work for inviting to Japan Mr. Antonio Negri, Italian Political Philosopher, in joint initiative with Science Council of Japan.

c. Japan-India Intellectual Exchange Program

(1) Japan-India Distinguished Visitors Program

In 2012, commemorating the sixtieth anniversary of Japan-India diplomatic relations, I-House and Japan Foundation jointly launched the Japan-India Distinguished Visitors Program. This program invites to Japan eminent Indian public figures who are proposing new values or innovative ideas to change the status quo of society. Fellows are invited for a period of 5-7 days to meet counterparts and leaders who are tackling similar issues in Japan in their area of expertise. The Fellows also engage in public seminars or lecture programs during their stay.

Mr. Siddharth Varadarajan, Editor of *The Hindu*, was selected as the first fellow in this program and visited Japan in late March. During his stay, in addition to a lecture at

I-House, Mr. Varadarajan engaged in a lecture at the Foreign Correspondents' Club of Japan (FCCJ) and various meetings with his fellow journalists and academics.

(2) Seminar Series on Contemporary India for Business Persons "Getting to Know India in Seven Days"

The number of Japanese businesses going into the Indian market is rocketing. While it is widely reported in the media when they enter the market, it is rarely the case that the media covers the stories of failures and retreats from the market. There are many factors behind these failures, but they all seem to come down to a lack of understanding of Indian society and culture and its people. Under such circumstances, a series of seven seminars was held to provide participants with an opportunity to learn about fast-changing contemporary India from a social, historical, political, religious, and philosophical perspective. The seminar series was attended mainly by business people who deal with India and Indian people on a daily basis.

(3) Melodies Eternally New—Songs of Tagore and the Tabla

This concert, held to commemorate the sixtieth anniversary of Japan-Indian relations, consisted of two parts: Part I featuring the songs of Rabindranath Tagore and Part II featuring Arif Khan on the *tabla*. Tagore set much of his own poetry to music that is still widely sung throughout India and Bangladesh. The I-House presented local Indian and Japanese musicians singing a selection of songs from Tagore's representative work, *Gitanjali*, in both Bengali and Hindi, with narration in Japanese. The second half of the program featured the young *tabla* percussionist Arif Khan from Calcutta. Khan is the 34th descendant in a line of esteemed *tabla* players from a lineage that stretches over 850 years. Khan demonstrated various musical patterns on the *tabla* and performed with *santour*.

2. Development and Training of Human Resources for Multicultural Exchange

The I-House continues to cultivate the talents of people destined to be the new leaders in international exchange.

a. Educational Programs

(1) Nitobe Kokusai Juku

The Nitobe Kokusai Juku is aimed at training young professionals from various organizations and corporations to become public-minded leaders who are equipped with a broad perspective and who are able to function in an international environment both in and outside the country.

The Principal of the Nitobe Kokusai Juku is Akashi Yasushi (Chairman of the International House of Japan), and the Coordinator is Professor Watanabe Yasuhi (Professor at the Faculty of Environmental Information, Keio University). The fifth Nitobe Kokusai Juku, organized between June and December 2012, invited prestigious lecturers. Six out of the thirteen lectures were open to the general public.

The "jukusei," or participants in the Juku, were first screened based on application materials (application forms and essays written on a designated theme), then selected through interviews. The fifth-year jukusei consisted of fourteen people from corporations, governmental entities, and international organizations, aged twenty-nine on average.

The Nitobe Kokusai Juku is supported by the Shibusawa Eiichi Memorial Foundation and the MRA Foundation.

(2) English Communication Seminar for Global Leaders

The English Communication Seminar for Global Leadership is an English-language seminar designed for those who work or wish to work at the intercultural interface. Participants develop sophisticated English communication skills by participating in a roundtable discussion with a global leader. The seminar focuses on communication skills that are important in international exchange and international business such as moderating, discussing, introductions and more. There are three practice sessions, a "global leader" roundtable, and a review session in which participants evaluate their own performance on DVD. (3) Japan Specialist Workshop (Library)

The Japan Specialist Workshop, jointly launched with the National Diet Library, has been carried out since Fiscal 2010.

Fiscal 2012 was the last year of the three-year project, and so the purpose this time was to review the results of the past workshops, to strengthen the relationship between Japanese and related overseas organizations, and to exchange opinions about future support for overseas Japanese Studies.

Representatives from the participants of the past two years of the Japan Specialist Workshop, Japanese Studies researchers, Japanese information specialists, and experts from Japanese Studies organizations in Japan attended the conference on February 19, 2013, to report and discuss the situation and projects promoting Japan specialists in each country. On the following day, a symposium was held at the National Diet Library, and the results of the conference were also presented there.

b. Cooperation and Coordination with Overseas Institutions

(1) U.S.-Japan Creative Arts Fellowships (Japan-U.S. Friendship Commission)

(2) Symposium on Building the Financial System of the 21st Century (Harvard Law School)

I-House and the Program on International Financial Systems (PIFS) of Harvard Law School co-organize an annual symposium "Building the Financial System of the 21st Century: An Agenda for Japan and the United States." The symposium, held alternately in Japan and the United States, brings together approximately a hundred participants, half from Japan and half from the United States, composed of senior government officials, politicians and their advisors, heads of financial firms, lawyers and consultants, scholars and a few media representatives. They gather for a two-day, off-the-record discussion of matters affecting the function and stability of the global financial system. Normally three major topics are discussed in detail, focusing on one or both countries, matters of regional concern in Asia, or of significance worldwide.

The fifteenth annual symposium, held in Karuizawa, Nagano, October 26-28, 2012, was attended by approximately 125 participants and was devoted to the following three topics:

- 1. Impact of the Euro-Crisis on International Finance
- 2. Key Challenges for Post-Crisis Adjustment of the Financial System including Banking, Insurance, and Securities Firms
- 3. Restoration of Fiscal Sustainability

3. Generation and Dissemination of Information on Cultural Exchange and Transnational Intellectual Cooperation

Sharing the fruits of intellectual dialogue and exchange becomes a basis for promoting intercultural understanding. The I-House conducts unique programs serving to enhance Japan's international intellectual contribution and to aid in the dissemination of reliable information, thereby contributing to the realization of a better global community.

The aim is to bring together leading novelists, poets, editors, and translators, and to encourage new dialogue about books from different countries and cultures. c. Exhibition in Commemoration of the March 11 Earthquake "Postcards from Japan—A Message From Tohoku Artists" and "Postcards to Japan"

The postcards in this exhibition were created by artists from Japan's Tohoku region right after the March 11 earthquake. When the major earthquake and tsunami struck the Tohoku region on March 11, 2011, it was extremely difficult to contact family and friends but the postal service quickly recovered, and postcards delivered the message that family and friends were safe. Inspired by the impact postcards can have, Iwate and Edinburgh-based sculptors Mr. Katagiri Hironori and Ms. Kate Thomson invited artists from the stricken region to make new works for an exhibition to tour the world. After touring various countries, these 22 postcards returned to Japan to commemorate the second anniversary of the disaster at I-House with the help of Mr. Katagiri and Ms. Thomson.

d. Publications

(1) LTCB International Library

Since August 2000, the I-House has assumed administrative responsibility for continuing the work of the LTCB Foundation, under the guidance of the policy and selection committees, to introduce selected books on the Japanese economy, politics, society and culture by Japanese authors to a wider international readership by translating them into English. This program is financed by the revenue and part of the principal of the fund established by endowment and other assets of the LTCB Library Foundation subsequent to its dissolution in 2000.

Two books are to be selected and translated, and 3,500 copies of each distributed by free gift to university libraries, institutions, public libraries, and cultural organizations around the world annually.



(1) Library Services 2000-2012


Although the number of users hardly changed compared with the last fiscal year, the number of materials lent and reference inquiries increased. It can be said that this shows a rise in demand for information services.

Service Activities

The study-bedrooms, which number 44 rooms, welcomed a total of 11,515 guests in the fiscal year 2012. The percentage of foreign guests remains high at 60 percent, showing the important role the House continues to play for visiting scholars and individuals involved in international culture and intellectual exchange.
